- The school uses some Fairtrade products in the Staffroom and for meetings
- Where appropriate, fair-trade ingredients are used/suggested in cookery activities
- They work with the Canteen to promote Fairtrade options for pupils where possible
- They raise awareness and promote the availability of Fairtrade options for Faculty purchasing (e.g. Footballs for PE, prizes and faculty refreshments)
- They explore using uniforms made with Fairtrade cotton

- They work with the PTA and other groups to ensure that Fairtrade products are available at school events
- Learning about Fairtrade is integrated into the school curriculum and whole school activities (e.g. assemblies)
- Fairtrade is promoted within the school (e.g. through use of display)
- One or more activities each year are organised during Fairtrade Fortnight
- Fairtrade is promoted within the local community in consultation with other local schools.

**The governing body will:**

- Support the school in the implementation of the policy

**MONITORING AND EVALUATION**

- The policy will be reviewed every 3 years
- The policy and activities related to Fairtrade will be reviewed by the Global Dimension Co-ordinator annually and reported to the Fairtrade Foundation if required.

- Work with the Canteen to ensure that the school provides some Fairtrade options for pupils
- Raise awareness and promote the availability of Fairtrade options for Faculty purchasing (e.g. Footballs for PE, prizes and faculty refreshments)
- Explore using uniforms made with Fairtrade cotton
- Work with the PTA and other groups to ensure that Fairtrade products are available at school events
- Ensure that learning about Fairtrade happens in a range of lessons and whole school activities (e.g. assemblies)
- Promote Fairtrade within the school (e.g. through use of display)
- Organise one or more activities each year during Fairtrade Fortnight
- Promote Fairtrade within the local community in consultation with other local school Fairtrade Steering Groups.

##### **The governing body will:**

- Support the school in the implementation of the policy

## **MONITORING AND EVALUATION**

- The policy will be reviewed every 3 years
- The policy and activities related to Fairtrade will be reviewed by the Fairtrade Steering Group annually and reported to the Fairtrade Foundation.
